### SECTION 4: First-Aid Measures

#### If inhaled

Remove individual to fresh air. Seek medical attention if breathing becomes difficult or if respiratory irritation develops. Give oxygen or artificial respiration if needed.

### SECTION 6: Accidental Release Measures

#### Personal precautions, protective equipment, and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Wear appropriate protective equipment and clothing during cleanup. Do not breathe dust/fumes/gas/mists/vapors/spray. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. ### Methods and material for containment and cleaning up

Dike the spilled material where this is possible. Stop leak if it can be done without risk. Absorb spillage to prevent material damage. Absorb in vermiculite, dry sand or earth, and place into containers. Prevent entry into waterways, sewers, basements, or confined areas. Following product recovery, flush area with water to remove residual contamination. Never return spills to original containers for reuse. Contaminated absorbent material may pose the same hazards as the spilled product. In the event of large spill or accidental release, notify relevant authorities in accordance with all applicable regulations.

### Precautions for safe handling
